Our home for the aged has all basic amenities for a respectable and dignified living for the homeless orphaned elderly.

It's in a permanent building in a vegetable / fruit garden spread in 4 acres. Currently there are about 30 senior citizens both female and male living in the facility. We provide shelter, food, health care and other recreation facilities such as cultural events, Spiritual programs, book reading, bhajans, temple visits etc.

We run blood donation camps regularly. Our main objective of running blood donation camps is to make blood available for even at small places as for any emergency blood requirements. Our blood donation camps have brought a lot of awareness about blood donation in the rural areas. So far we organized around 2000 Blood units from rural donors and delivered to Red Cross Society/ Andhra Pradesh Vaidya Vidhana Parishad Blood Banks.

In the last 15 years we managed all our activities of charity with our own personal finances and some contributions from individuals like family and friends within our circle.

However, due to escalating costs and paucity of funds, we are struggling to run our charity to serve more people.
